





About Yayasan Hijau Malaysia





Yayasan Hijau Malaysia integrated these five thrusts into its strategic framework to plan and implement its programmes and fulfil its objectives.




Figure: Five Strategic Thrusts for the development of conducive ecosystems for Green Technologies growth





Resigned from the Board of Trustees on 07 August 2018

Datuk Seri Panglima Dr. Ongkili started his career as a lecturer at Universiti Pertanian Malaysia (now known as Universiti Putra Malaysia). Later he held several senior research positions with the Institute of Strategic and International (ISIS) Malaysia (1985-1987). He was appointed as Executive Director/Chief Executive Officer of the Institute of Development Studies (Sabah) from 1991 to 1994.

His involvement in politics began in the 1994 general election when he contested for Langkon State Seat under the ticket of Parti Bersatu Sabah (PBS), and won handsomely. He has been the Member of Parliament for Kota Marudu, Sabah since 1995 and a three-term member of the Sabah State Legislative Assembly from 1994 to 2008.

After 23 years as PBS Deputy President, on Jan 6, 2017, Datuk Seri Panglima Dr Maximus Johnity Ongkili took over as acting president of PBS with immediate effect after the then-party president Tan Sri Joseph Pairin Kitingan passed the presidency baton to him.

In the 14th General Election in May 2018, Datuk Seri Panglima Dr. Ongkili has successfully retained his parliamentary seat of Kota Marudu. Datuk Seri Panglima Dr. Ongkili was first appointed into the Federal Cabinet in 2004 as a Minister in the Prime Minister's Department where he was placed in charge of National Unity and headed the initiation of Khidmat Negara conscription program, from March 2004 to March 2008. After the March 2008 General Election, he became the Minister of Science, Technology and Innovation. He retained the Kota Marudu parliamentary seat in the 2013 General Election and was appointed as the Minister of Energy, Green Technology and Water. Datuk Seri Panglima Dr. Ongkili graduated with Bachelors of Agricultural Science from La Trobe University in Melbourne, Australia and later obtained his Ph.D. in Agricultural Economics from the same university.

Datuk Seri Ir. Dr. Zaini Ujang was the Secretary General, Ministry of Energy, Green Technology and Water, Malaysia since 5 August 2016 until May 2018. He was the Secretary General Ministry of Higher Education, Malaysia since July 2015 – August 2016 and the Secretary General II, Ministry of Education Malaysia (June 2013 – July 2015), the fifth Vice-Chancellor of University Technology Malaysia (October 2008 – May 2013). He is first recipient of the prestigious Merdeka Award for the category of Outstanding Scholastics Achievement in 2009.

He has written more than 250 scientific papers published in leading academic journals and proceedings, and 33 books on environmental engineering, water sustainability, higher education and learning innovation, and published more than 1000 articles in mainstream media since 1988.

He is registered as a Professional Engineer (Malaysia), Chartered Engineer (UK), Chartered Scientist (UK), and Chartered Water and Environmental Manager (UK).

Datuk Seri Ir. Dr. Zaini Ujang graduated in Chemical Engineering with Honours from Universiti Teknologi Malaysia. He pursued a Master Degree and Ph.D. in Environmental Engineering in University of Newcastle, United Kingdom. He completed the Advanced Management Program in Harvard Business School, Harvard University.



Datuk Loo Took Gee holds a Master Degree in Policy Science from Saitama University, Japan, Diploma in Public Administration from the National Institute of Public Administration (INTAN), Kuala Lumpur and Bachelor of Arts (Honours) Degree from University of Malaya, Kuala Lumpur.

Dato' Sri Zool Azha Yusof started his career as an Administration and Diplomatic Officer for the Services Division, Public Service Department from 1981 to 1982. From 1982 to 1984, he served as the Deputy Director (Services) II for the Services Division, Public Service Department. Dato' Sri Zool Azha had a shift in his career between 1984 and 1988 to serve as a Student Welfare Officer for the Ministry of Education. For a short duration in 1988, he was in the Group Career of the Public Service Department. Moving on, he joined the Ministry of Labour from 1988 to 1991 as an Administration and Diplomatic Officer. Then, again for a short duration in 1993, he was in the Group Career of the Public Service Department. In the same year, he became an Administration and Diplomatic Officer (M3) for the Ministry of Housing and Local Government. In 1993 Dato' Sri Zool Azha graduated with Master in Public Policy from University of Wisconsin, U.S.A. He then served as the Chief Assistant Secretary for the Ministry of Housing and Local Government between the years of 1993 and 1998.

From 1998 until 2002, he was a Deputy Director in the Selangor State Development, Implementation Coordination Unit, Prime Minister's Department. He then served as the Chief Assistant District Officer (Land) for the Selangor State Secretary from 2000 until 2002. From 2002 to 2004, he became the Petaling District Officer for Selangor State Secretary. Moving forward, he then served as the Director for the Selangor State Land and Mines Director Office between 2004 and 2006. From 2006 to 2008, he became the Director General for the Department of Director General of Land and Mines. Dato' Sri Zool Azha switched to a different ministry when he served as the Deputy Chief Secretary 1 for the Ministry of Natural Resources and Environment between 2008 and 2009. For the following 6 years, between 2009 and 2015, he became the Chief Secretary for Ministry of Natural Resources and Environment. His contribution among others was serving as the Chairman on the Board of the Forestry Research Institute of Malaysia (FRIM) in 2016 and providing consultancy between 2009 and 2015 on policy making in regards to biodiversity in the same organization.

She is the Managing Director of ONE KLCC Sdn Bhd, the developer of the 35-storey ONE KL featuring “94 Apartments, 95 Swimming Pools” and sits on the board of various companies of the CMY Capital Group. She is also a member of the Yayasan Hijau Board of Trustees and the Blue Ocean Corporate Council (BOCC).

Carmen Chua graduated with a Bachelor's of Science in Economics with First Class Honours from the London School of Economics and Political Science, United Kingdom, in 2004.

Dr. Hajah Dayang Aminah Ali started her career as a Tutor at Universiti Kebangsaan Malaysia in 1985. From 1989 to 1994, she served as a Lecturer at Universiti Kebangsaan Malaysia, Sabah. She was then appointed as a Senior Lecturer in the Faculty of Medicine at Hospital UKM, Jalan Tun Razak, Universiti Kebangsaan Malaysia from 1994 to 2004.

In the subsequent years between 2007-2014, she was elected as the Chief Executive Officer (CEO) of Kolej Yayasan Sabah (KVS) in Kota Kinabalu. She became the Deputy Vice Chancellor of University College Sabah Foundation (UCSF) in Sembulan, Kota Kinabalu between 2014 and 2016.

From the year 2014 until present, she sits on the Board of Trustees of Yayasan Hijau and Yayasan Angkasawan. From the beginning 2016, she has been appointed as Ketua Wanita for PERDASAMA Sabah. She also serves as the Director of Sabah Animation and Creative Content Centre (SAC3) in Penampang, Kota Kinabalu since 2016 until today.

Dr. Hajah Dayang Aminah Ali went to Maktab Sabah, Kota Kinabalu in 1974. In 1975, she enrolled at Matrikulasi Universiti Kebangsaan Malaysia (UKM) in Limauan, Sabah. She obtained her B.Sc. Second Upper Class in Food Science and Nutrition from UKM in 1982; and went on to obtain a M.Sc. in Nutrition from Queen Elizabeth College University of London, UK in 1984. In 1989, she secured her Ph.D. in Environmental Health, King's College University of London, UK; and M.Sc. in Clinical Counselling, University of Bond, Gold Coast Australia. Among the notable awards she has received was she was nominated as Tokoh Maal Hijrah in Sabah in 2013.



MESSAGE BY THE CHAIRMAN



Dear readers,

Naturally, to take care of our bodies, we eat well, exercise and sleep enough. That's how we take care of our internal environment. What we also have to be concerned about is the environment that surrounds us; the air, soil, water and ecosystems are equally as important for our health and the health of others. Taking care of our internal environment is less meaningful if we ignore the importance of environmental conservation because what is brought into our body is through what is inhaled from the outside. The link between human and planetary health is becoming more apparent.

Malaysia is blessed with abundant resources. The rapid development of the country since independence was mainly supported by the utilisation of natural resources. Over the past six decades, Malaysia has evolved from a primary economy dependent on mining, rubber and oil palm plantation, to a manufacturing-based secondary economy, morphing into a service-based tertiary economy. Natural resources have served the nation well as the growth engine. For the benefits of the existing, as well as the future generations, it is crucial for the country to embark on green growth. To support this development strategy, green technology has been identified to catalyse sustainable economic growth. We have become increasingly clear in our direction and confident in setting out more programmes to achieve our objective and fulfil our mandate.

Who should protect the environment?

Everyone, from government to individuals of all ages and abilities, plays an important role as the stewards of the environment.

Apart from the involvement of the young people, initiatives by Yayasan Hijau Malaysia have also received attention and responses from government, corporate bodies and other NGOs. The involvement of these groups is significant and meaningful as the awareness and responsibility for preserving the greenery of our Earth particularly in Malaysia is on the shoulders of all. Hence, the involvement and collaborations with various parties in their respective capacities have created a harmonious cooperation.

Based on its strategic framework and continuous effort, Yayasan Hijau Malaysia has carried out several flagship programs namely, The Green Guardian Program, Karnival Inovasi Teknologi Hijau, Trees Planting & Parks Adoption, Program Sekolah Tunas Hijau, Jelajah YaHijau (YaHijau Roadshow), Green Technology Curriculum Modules and Sustainable Program for Secondary Schools and Let's Break-Up With Single Use Plastic Campaign.

The introduction of the Green Technology Modules for secondary school students has entered the final stage of its development. We completed the development of the Green Technology Curriculum Modules and the Teaching Aids by the end of 2018.

We have published ten modules which will be incorporated in five science stream subjects. These subjects will be integrated into the upper form school syllabus starting from 2019. The students are set to be tested on it in Sijil Pelajaran Malaysia (SPM) examination starting 2020. This programme marked a very important milestone for Yayasan Hijau Malaysia throughout its establishment and is expected to have a significant impact on the Government's initiatives towards building a green and sustainable nation.



Another significant milestone achieved by Yayasan Hijau Malaysia is the Green Guardian Project. The Green Guardian is an entertainment cum educational (edutainment) oriented program targeting students in pre-school and primary school. Since it started its operations from June 2018, Green Guardian has been actively running its programmes at the Green Guardian Centre at The Curve, Kota Damansara as well as on the road through the Green Guardian Mobile Program and Green Guardian Outdoor programmes in our effort to reach out to the children living outside Klang Valley.

Moving forward, the Ministry is looking to have more collaborations between Yayasan Hijau Malaysia and other Government agencies, private sectors as well as the public in promoting the country's sustainability agenda. The use of technology such as interactive media and social media in Yayasan Hijau Malaysia's programs and promotional activities is also crucial to attract the interest of the younger generation and in ensuring its relevance in a fast-changing world.

I would like to take this opportunity to thank all Yayasan Hijau Malaysia's stakeholders for their support, feedback and contribution that has propelled the agency to where it is today. My utmost appreciation also goes to the Yayasan Hijau Malaysia team for their tireless dedication and commitment in carrying out the Government's green agenda.

With the country moving towards greater awareness on green lifestyle, I am confident that Yayasan Hijau Malaysia's role and importance will grow even bigger as the society progresses. An exciting future lies ahead for the agency, and the Ministry looks forward to witnessing the fruitful outcomes of Yayasan Hijau Malaysia's programmes in the years to come.

From 2016, Yayasan Hijau Malaysia expanded the team to focus more on the objectives of the existing and new flagship programmes. Each department could focus on their own designated roles. The years of 2017-2018 were a successful continuation of the previous year in implementing flagship programmes such as the Jelajah YaHijau series, the Karnival Inovasi Teknologi Hijau events, the Tree Planting and Park Adoption programme and the launch of the Green Guardian project in 2018. These programmes have succeeded in gathering young people to participate in the activities planned.

Our Achievements

Jelajah Yahijau

Jelajah Yahijau programme has continued to be a key programme under Yayasan Hijau Malaysia. In 2017, Yayasan Hijau Malaysia resumed its Jelajah Yahijau series in Sabah. It was successfully held in four locations and an additional of two locations in 2018 within the state. This series of Jelajah YaHijau programmes have received great response from the local communities through their active participation.



Karnival Inovasi Teknologi Hijau (KITH)

In 2017, Karnival Inovasi Teknologi Hijau (KITH) was held in two locations; Kuala Lumpur Convention Centre (KLCC) and Malaysian Green Technology Corporation (MTGC) and in 2018, KITH was held in Pulai Spring Resort, Johor. This carnival was participated by schools from 16 states including the Federal Territories of Kuala Lumpur, Putrajaya and Labuan. The activities developed for the carnival were able to attract the students to explore more on the sectors related to Green Technology. This programme was able to change the perceptions of the students towards the field of Green Technology and guided them on how to apply this knowledge in fulfilling the needs of life while preserving the environment.



Transformasi Nasional 2050

The Ministry of Energy, Green Technology and Water (KeTTHA) was committed in fulfilling the Government's vision of National Transformation 2050 (TN50). KeTTHA focused on the elements of energy, green technology and water in making this vision a success. As an agency under KeTTHA, Yayasan Hijau Malaysia was actively involved in dialogues associated with the implementation of TN50 organized at ministry level in its effort to support and uphold the vision of TN50. We were also involved in conducting several dialogues held in Labuan, Sabah and Terengganu to spread the messages on TN50. Apart from that, we have fitted in activities to promote the Government's vision of TN50 and gathered the aspirations from local communities in our programmes such as in Jelajah Yahijau series.



Green Guardian

In 2018, another major milestone was achieved by Yayasan Hijau Malaysia with the launch of the Green Guardian programme. The Green Guardian centre was established with the aim to educate children in kindergarten and primary schools on issues related to the environment and green practices that need to be adopted to preserve it. These messages are delivered through a fun learning experience using high technology and interactive games.

We have also launched the Green Guardian Mobile unit in our effort to reach out to the children living outside Klang Valley to ensure that everyone is included in learning about saving the environment.



The year of 2018 was also meaningful to Yayasan Hijau Malaysia where we moved from Midvalley to our new office in Menara PJH, Putrajaya. The launch of the new office took place in February 2018, officiated by the Minister of Energy, Green Technology and Water who is also our Chairman of the Board of Trustees, Y.B. Datuk Seri Panglima Dr. Maximus Johnity Ongkili. All these achievements will not be a reality without the support from the Ministries we are under as well as other agencies.

Challenges

Like other organizations, Yayasan Hijau Malaysia has faced and overcome various challenge over the years. We have to compete with a large number of organizations who also focus and rely on green factors. Green factor is wide and huge, it has positive and negative sides to it. We have to find our own niche. We set young generations as our target and we use education as the platform to achieve our objective. Another huge obstacle for YaHijau is the lack of funding. As a non-profit organization, finding funds for the programmes has been an ongoing challenge. We make continuous efforts to reach out for more collaborations with Non-Government Organizations (NGO), corporations, ministries and local communities to create the awareness in sustaining the environment.



Being an agency under the Ministry of Energy, Green Technology and Water (KeTTHA) and then subsequently put under the Ministry of Energy, Science, Technology, Environment and Climate Change (MESTECC) from 2018 onwards has been among the contributing factors for Yayasan Hijau Malaysia in successfully carrying out our programmes. Not to be missed out our partners and collaborators from various agencies who have been working hand in hand with Yayasan Hijau Malaysia to make our programmes a success.

Today, Yayasan Hijau Malaysia is acknowledged locally and internationally. It is gaining momentum in achieving its objective on spreading the message and awareness on green practices. The programmes set out by Yayasan Hijau Malaysia involving many collaborators and partners received positive responses from the community and the objective to preserve the environment has become the agenda of our society as a whole.

Making Our Way Forward

In line with the change of the patron where it has been put under MESTECC since 2018, the relevance to emphasize another element in Yayasan Hijau Malaysia's objectives was climate change. Previously, there was more focus on the elements of energy, water as well as promoting green technology and environment protection in our programmes. Now there is the element of climate change added in Yayasan Hijau Malaysia's objectives. We have started this move with the launch of the **Let's Break-up With Single-Use Plastic** campaign in September 2018. Plastics are made from fossil fuels—four percent of the world's annual petroleum production is converted directly into making plastics, and another four percent gets burned to fuel the process. On top of whatever other problems we might have with plastic, surely this non-renewable product must be a net contributor to our global climate problem. Therefore, we believe that this campaign is a good start.



Yayasan Hijau Malaysia aims to have more programmes that include environmental issues to be developed in the coming years. We see a change of landscape in geopolitics with the trade war between two giant countries. This trade war poses a great impact to the global economic and industries directly and indirectly. This development will impose pressure on the industrial players which will push them into survival mode to sustain in the dire period. The struggle to survive the economic turbulence may result in the green element to be taken for granted or even worse, forgotten.



Yayasan Hijau Malaysia will work our way to introduce new elements that fit with the current changes and integrate these elements in our programmes and perhaps include these elements in the academic module to be taught in schools. Meanwhile, we will still be focusing on the single-use plastic issue with education being the medium to deliver the message. While for 2019, the Green Guardian program will be the focus model for Yayasan Hijau Malaysia to implement its various activities.



We are also blessed with a set of young and dynamic team at Yayasan Hijau Malaysia who have been very dedicated in striving to achieve the visions and missions of our organization with their energy as well as abundance of fresh and versatile ideas.

Our Aspiration

For the coming years of 2019 and onwards, Yayasan Hijau Malaysia will continue with our current programmes and further refine it to sustain and fit with the current needs. I hope that Yayasan Hijau Malaysia's will have more opportunities to collaborate with other NGO's, Corporations and local communities in our programmes and towards a sustainable future.

Yayasan Hijau Malaysia will multiply and improves our strategies and efforts to instill the awareness to cultivate green practices so much so that they leave a deep impact within the heart of young generations.

Youth Programmes

Objectives and Impact

Jelajah YaHijau

The Jelajah YaHijau programme is an annual programme that focuses on the efforts to promote and encourage communities' understandings and interests on green lifestyle practices and green technology applications. This programme targets students from primary school up to higher learning institutions.

This programme is a continuous initiative of the Ministry of Energy, Science, Technology, Environment and Climate Change (MESTECC) through Yayasan Hijau Malaysia.



The Jelajah YaHijau programme aims to share ideas and to expose the public, especially the community, on the importance of sustainable technology applications and green living practices in everyday life. This is another Government-friendly approach in creating public awareness and triggering a change in the minds of the society towards Green Technology development agenda in the country. This in turn will make the green agenda a platform for community integration in an effort to drive sustainable economic growth. It is implemented through activities such as eco workshops, Green Runs and green-related competitions amongst students from various schools.



In 2017 and 2018, Jelajah YaHijau programme continued its roadshow series in 6 locations across Sabah namely Matunggong, Tenom, Keningau, Telupid, Tawau, Kota Marudu & Tambunan. Various activities were prepared to engage youth in this programme such as Senamrobik, talk on green practices, community sports (Pertandingan Inovasi Sekolah, Pertandingan Gusti Lengan, Pertandingan Anyaman Ketupat, Pertandingan Menyumpit, Pertandingan Bowling Kelapa) and exhibition. Apart from that, local vendors also get the opportunity promote and sell their products at the booths provided in this programme.

PROGRAM INOVASI YAHIJAU In Conjunction with Urban Environmental Accords (UEA) Melaka Summit 2017 Conference

Melaka State Government in collaboration with Alor Gajah Municipal Council (MPAG) has successfully organized the Melaka Summit Urban Environmental Accords (UEA) 2017 Conference at A 'Famosa Resort, Alor Gajah on 7-9 September, 2017. The objective of the conference is to discuss in detail the plan action based on the Green State Green City Masterplan and the United Nations green indicators (UN-UEA).

In conjunction with this conference, Yayasan Hijau Malaysia was invited to participate in promoting and creating public awareness on the green technology practices and how to apply it towards youths.

In this regard, an innovative and invention program using waste materials was organized in collaboration with the MPAG and Ministry of Energy, Green Technology and Water (KeTTHA). The program named was attended by 50 diploma students from University Kuala Lumpur Malaysian Institute of Chemical and Bio-Engineering Technology (UniKL-MICET).



PROGRAM INOVASI YAHIJAU In Conjunction with PROGRAM KAMPUS LESTARI UNIVERSITI KEBANGSAAN MALAYSIA 2017

On **24 October 2017** (Tuesday), Universiti Kebangsaan Malaysia (UKM) organized the UKM Sustainable Campus Program of 2017 at Dewan Perdana and at the main area of Faculty of Social and Humanities (FSSK). The program was officiated by the Dean of FSSK, YBhg. Prof. Dr. Mohd Fuad Mat Jali.

The objective of this program is to enhance knowledge, awareness as well as continuous practice towards making UKM a sustainable campus and evaluate the level of appreciation and awareness of FSSK and SMEs on the current implementation and sustainability initiatives in UKM. In addition, the program aims to promote a healthy lifestyle and environmental care towards the well-being of the community.

In conjunction with this program, Yayasan Hijau Malaysia was invited to coordinate the Design and Innovation Competition from recycled materials and also to open a booth for exhibition. The competition was participated by 5 groups comprising a few faculty students from UKM. All groups managed to produce unique products within 2 hours and 30 minutes with reuseable concepts in this competition.

Education

The education platform is seen to have a broader reach to the youth. By using this platform, Yayasan Hijau Malaysia has planned and introduced several key programmes that are expected to attract more young people to engage in green practice activities. Yayasan Hijau Malaysia sees the importance of character building during the age of formation, thus, the programmes targeting at the students as young as five years old up to secondary school students.





Green Guardian

The Green Guardian centre was launched in 2018 and located at The Curve, Kota Damansara. This project is supported by the Discovery Channel. The Green Guardian is an interactive educational centre designed for kids aged between five to 12 years old and aims to educate children to adopt effective measures to promote a more livable and sustainable living environment for all.



Mission

To teach kids the importance of conserving valuable natural resources and protecting the environment from harmful pollution through a series of educational games and interactive display.

Vision

To be the leading children's digital edutainment center focusing on environmental preservation.





The Green Guardian Edutainment Centre makes use of the technology advancement to satisfy the children's curiosity and benefit them in their learning experience. This centre is equipped with the state-of-the-art equipment and simulation effects to create an exciting learning experience. Children can look forward to completing fun and interactive games using digitalized vibrant visual displays and hands-on tools. They can touch, see and feel all the colourful exhibits with the assistance from the centre's staff.

This approach of learning deviates from the traditional classroom-oriented learning by educating children through a fun, innovative and experiential manner.

Children will learn and understand the concept of sustainability and going green through an interactive classroom with highly touch-based technology and curated video content. Children will be exposed on issues related to the environment and they will be guided on how to care and conserve the environment to save the Earth.



This centre also introduced a 'One for One' programme, which encourages children to swap books or other reading materials to preserve the environment and promote a reading culture.

The Green Guardian has carried out several outdoor programmes in order to reach out to the children living in Sabah and Sarawak. Children will get to experience the same interactive games and activities that are provided at the Green Guardian Centre.

The Green Guardian also has launched the Green Guardian Mobile unit in our effort to enhance the learning experience of the children living outside Klang Valley and in the rural areas. In 2018, the Green Guardian Mobile has also conducted a series of tour programme in the southern region of Peninsular Malaysia and visited schools in Malacca and Johor.

GREEN TECHNOLOGY Modules



The Green Technology Modules programme is a project under The Development of Green Technology Knowledge, Implementation and Awareness Activities Through Cross Curriculum Approaches in Secondary Schools towards Sustainability Education programme.

This programme is a joint collaboration between Yayasan Hijau Malaysia, Centre for Education and Training for Renewable Energy, Energy Efficiency and Green Technology, Universiti Sains Malaysia (CETREE & GT, USM) and also the Ministry of Education (MOE) through the Curriculum Development Division (CDC). This project is funded by Malaysian Electricity Supply Industries Trust Account (AAIBE). The Green Technology Modules were introduced to educate the students to a more environmental-friendly branch of science and technology based on green technology philosophy as an alternative to conventional methods and technology.

These modules will be integrated in the secondary school syllabus and will begin to be taught to form 4 students in the beginning of 2019. Students will be tested in the Sijil Pelajaran Malaysia (SPM) examination on these subjects beginning of 2020.

Through these modules, students will be given an insight of current environmental issues we are facing today as an effect from the uncontrolled development as well as mismanagement of resources and waste. Students will also be exposed and guided on another way of managing the resources and waste as well as new approach in inventing new innovations to meet the need of life in a sustainable manner. In the long run, they will be the change maker in the industrial practice who are able to make sustainable judgements and decisions.

The Green Technology Modules will be incorporated into five subjects at secondary school level: Science, Biology, Physics, Chemistry and Sustainable Basis. Each subject comes with a set of two modules consisting of Teachers Guide Book and Students Activity Book to facilitate the teaching and learning process. The components covered in these modules among others are energy resources and energy efficiency, building management, water resources and management, and Green Technology in transportation sector.



The development of the Green Technology Modules was implemented in four stages starting from 2015 and set to be completed in 2019.



In Phase 1, a guideline was established to set the direction and methods of implementing Green Technology modules in schools. A few series of workshops on Green Technology were conducted to strengthen the knowledge of the specialist teachers involved in writing the modules. The modules were improved and refined to ensure the effectiveness and usability of these modules.

The Phase 2 of this project involved the printing of the modules which has been fully completed in January 2018. The modules and teaching aids were printed and distributed to the teachers to be used in the training for teachers which were planned to be conducted starting in the end of October 2017. Apart from the printed copies, these modules can also be obtained and downloaded from CETREE's website.

A series of workshops conducted nationwide to provide training on Green Technology Modules to the teachers to heighten the awareness and strengthen their knowledge on subjects related to Green Technology. It was also purported to prepare the teachers to transfer the knowledge to the students.

The Green Technology learning in schools was integrated and stabilized through activities organized involving participations from schools across Malaysia such as the Karnival Inovasi Teknologi Hijau. This carnival will be an early exposure to the students on the Green Technology subjects before being taught in schools beginning of 2019. Components associated with Green Technology and sustainability were introduced through competitions set up in this carnival.

The Green Technology Modules programme is a big milestone for Yayasan Hijau Malaysia. This programme is expected to give a major impact to the Government's green initiative based on the scale of its implementation since it involves secondary school students across the nation. This programme will keep Malaysia on track towards becoming a green and sustainable nation.



Karnival Inovasi Teknologi Hijau

The Karnival Inovasi Teknologi Hijau (KITH) is an annual event organized in collaboration between the Ministry of Energy, Science, Technology, Environment and Climate Change (MESTECC) and previously with Ministry of Energy, Green Technology and Water (KeTTHA). Other collaborators include the Ministry of Education Malaysia (MoE) and the Centre for Education, Training & Research in Renewable Energy and Energy Efficiency (CETREE). This carnival is part of the initiatives under the implementation of the Green Technology Modules programme purported to prepare the teachers and students for these new subjects. During this carnival, several competitions were held which include the elements of Green Technology.

Seven categories of competition were developed by the CETREE Secretariat together with the officers from State Education Department (JPN), experienced teachers and officers from Bahagian Kokurikulum dan Kesenian (BKK), Ministry of Education (MoE). Officers from the State Education Department also took part to facilitate the carnival and assisted on the technical matters. CETREE appointed experts specializing in Green Technology from various IPTAs and IPTSs as judges to evaluate and judge the categories contested in the competitions.

In 2017, the carnival was held from 11th-13th of October at two locations which were the Kuala Lumpur Convention Centre (KLCC) and the Malaysian Green Technology Corporation (MGTC), Bangi.

For the year of 2018, the Karnival Inovasi Teknologi Hijau was held on the 21st & 23rd of November which took place in Pulai Spring Resort, Johor Bahru. This programme was participated by 16 states including the Federal Territories of Kuala Lumpur, Labuan and Putrajaya.

Each contingent from the states is represented by a State Education Department official, team manager, teacher and the secondary school students from participating schools.



The competitions organized in the KITH are: Green Cooker Challenge, Pertandingan Inovasi Tenaga Biojisim, Pertandingan Green Technology Show, Pertandingan Reka Cipta Inovasi Teknologi Hijau, Xplorace Teknologi Hijau & Kuiz Teknologi Hijau, Pertandingan Reka Bentuk Bandar Teknologi Hijau, and Solar Vehicle Challenge. Through these competitions, students were given the opportunity to put their knowledge into practice and apply the benefits to themselves and the nation in the long run.

Pertandingan Reka Cipta Inovasi Teknologi Hijau

Pertandingan Reka Cipta Inovasi Teknologi Hijau is a game held to give exposure and to promote the culture of innovative inventions of Green Technology focused innovation. This game is expected to open the minds of the participants to better appreciate the environment with the design of Green Technology.

Pertandingan Inovasi Tenaga Biojisim

Pertandingan Inovasi Tenaga Biojisim is a competition where participants are required to generate energy from plants' waste such as fruit skins, leaves, timber or any other plant resources which will be processed to turn it into carbon. This competition aims to produce dried cells (batteries) from materials (carbon source). The competing schools will choose the best carbon source of their choice based on the outcome of the research and experiment conducted at their respective school.

Pertandingan Xplorace

Pertandingan Xplorace is an outdoor competition where the learning of Green Technology is applied through questions and assignment solutions. Meanwhile, Pertandingan Kuiz Teknologi Hijau is a competition where students' proficiency and knowledge in Green Technology sectors are tested. Both competitions challenge students' knowledge on the Green Technology in all sectors.

The Green Cooker Challenge

The Green Cooker Challenge is one of the competitions pertaining to Renewable Energy, Energy Efficiency and solid waste management. This match consists of the elements of project functionality, design, project reporting, as well as decoration of the contest's materials. Each team is required to produce a real solar stove capable of collecting high heat energy to be used to cook liquid and solid based ingredient. The solar cookers designed must also be portable. Through this competition, students can understand, practice and apply the concept of 3R in waste management sector of the Green Technology namely reduce, reuse and recycle.

The Green Technology Show

The Green Technology Show is a competition related to Green Technology. The theme of the show can be based on any sectors of Green Technology such as Energy, Transportation, Green Building, Industrial, Agricultural, Forestry and Land Use, Solid Waste and Water Waste Management, and ICT. Each show must consist of at least three issues related to the chosen theme and the show must be creative, hands-on, practical and fun.

Pertandingan Reka Bentuk Bandar Teknologi Hijau

Pertandingan Reka Bentuk Bandar Teknologi Hijau is aimed at producing a model city that applies the concept of green technology sectors namely energy, transportation, building, solid waste and water waste management, industry, agriculture (forestry and land use) as well as the information and communication technology (ICT).

The Solar Vehicle Challenge

The Solar Vehicle Challenge is a Green Technology based competition involving the energy and transportation sector. The competition is conducted to evaluate the understanding, creativity and innovation of the participants in successfully producing a solar vehicle that is able to withstand a circuit race. This match is an improved concept from the original version of the 'Solar Car' match by incorporating a competition concept that uses higher skills and requires broader understanding in the field of diesel. In fact, this competition will provide the basic ideas that can help to promote research and development processes in the field of solar vehicles. This approach is also a basic idea for future technology in heavy vehicle management as well public transportation.

PROGRAM SEKOLAH TUNAS HIJAU



Program Sekolah Tunas Hijau is a joint initiative between Yayasan Hijau Malaysia, Centre for Education and Training for Renewable Energy, Energy Efficiency and Green Technology, Universiti Sains Malaysia (CETREE & GT, USM), Yayasan Hasanah and Ministry of Education in the effort to promote and educate on green lifestyle, the importance of green technology and sustainability to the young generations from grassroot level. This programme was jointly funded by Yayasan Hasanah and Suruhanjaya Tenaga.

This programme ran for six months beginning in March 2018 and ended in August 2018. 25 schools around Klang Valley were chosen to participate in this programme. This program's objective was to guide the students to foster green practices in everyday life. The right attitude and behavior can be formed from an early age.

Thus, through this programme, students were guided to adopt conservative practice in energy consumption and wise practices of consuming and managing water and solid wastes.

The Schools Green Practices Activity Manual was developed and completed in April 2018. This manual provided a comprehensive overview and guidelines to run this programme. A one-day training workshop was conducted to train the teachers from participating schools with relevant skills, knowledge, attitudes and ideas to come up with activities to achieve the objectives of this programme. The students will plan, evaluate and apply green practices at school based on the guidelines underlined in the manual with proper guidance from the teachers. The focus elements in this programme concentrated on the prudent use of water, energy efficiency and solid waste management through 3R approach namely reuse, reduce and recycle.

A panel of experts appointed to perform the evaluation to determine the winners of this programme. This panel visited participating schools for the evaluation. Students from the participating schools were required to prepare a presentation regarding the activities related to green practices conducted at their school.

First place of the Program Sekolah Tunas Hijau went to Sekolah Menengah Kebangsaan Sungai Besi followed by Sekolah Menengah Kebangsaan Perempuan Air Panas as the first runner up. Third place went to Sekolah Menengah Kebangsaan Bandar Sunway, fourth place was won by Sekolah Menengah Kebangsaan Padang Tembak and Sekolah Menengah Kebangsaan Bangsar came in fifth.



This programme was conducted to achieve four objectives targeted, namely:-

- i) To achieve the increment of 95% acceptance of green practices as a sustainable lifestyle through multiple impact
- ii) To reduce electricity consumption by 5%
- iii) To reduce water consumption by 3%
- iv) To reduce solid wastage by 3% in the effort to reduce carbon footprint in Malaysia

A survey conducted after the programme to evaluate the level of awareness on energy efficiency, water-saving and waste reduction amongst the school community showed an average percentage reached at 82.71%. 60% of the schools involved achieved the target of at least 5% reduction in energy usage. 44% of the schools achieved the target of at least 3% reduction in water usage. 32% of the schools achieved the target of at least 3% reduction in solid waste. This Program Sekolah Tunas Hijau was set as a bench mark for future programmes related to the green practices in schools.

Meanwhile, students participated in this programme were expected to maintain these green practices at schools even afterwards and bring the influence back home to educate the rest of their family members. This is one way of spreading the message to embrace green practices. It takes a single brick to build a building. It takes a small step to make a big leap. It takes one person to begin with the right the move and it takes a single-family unit to make a big change in a society.

Environment

In our effort to engage the youth to care for the environment, Yayasan Hijau Malaysia developed two key programmes mainly to focus on greening and cleaning the Earth.

TREES PLANTING AND PARK ADOPTION PROGRAM



Under this program, the sponsorship received would be exempted from corporate taxation under the directive of Ministry of Finance, via Yayasan Hijau Malaysia.

Planting more trees keep the ecosystem in balance and preserve the environment. By planting and caring for trees, we improve our surroundings, reduce pollution, protect us from excess carbon dioxide and lower the energy costs. Planting more trees help to combat climate change and is also a way to give back to nature to aid in the restoration of homes for wildlife, food sources and medicinal properties that only trees provide. As trees grow, they protect the Earth from harsh weather conditions, hence enabling us to live longer and more comfortably. Trees also shield us from the ultra-violet ray which has been the cause of the skin cancer.

In our effort to support the Government's objective to increase the amount of green spaces in Kuala Lumpur by 2020, Yayasan Hijau Malaysia in collaboration with PEMANDU, Think City (under Khazanah Nasional Berhad) and Local Municipal Councils (PBT) have initiated the Trees Planting Sponsorship Programme.

The Trees Planting Sponsorship Programme has been established to increase the awareness amongst citizens on the need to maintain the balance between physical development and environment protection in order to ensure livability in Malaysia.

The Trees Planting Sponsorship Programme also extends an opportunity for Corporate entities to give back to the society in the form of Corporate Social Responsibility (CSR) and connect with the surrounding communities for a great cause. Apart from that, trees planting brings diverse groups of people together where it provides an opportunity for community involvement and empowerment that improves the environment and the quality of life. All cultures, ages and groups have an important role to play in trees planting.

Under this initiative, Corporate entities can choose from the sponsorship packages offered under this program. PBT will identify available spaces/land for trees planting program. The PBT also will advise on tree species required to be planted at the gazetted zones. The cost of sponsorship also include two years of maintenance for the trees.



The awareness to restore green spaces has gained more the attention from organizations as well as the Malaysian public. Yayasan Hijau Malaysia welcome more participations and sponsors for this programme to realize our greening agenda.



Along the years of 2017-2018, Yayasan Hijau Malaysia has organized several trees planting activities around Kuala Lumpur and Selangor. This began with Program Hutan Kita which was held on the 27th of February 2017 at Taman Metropolitan Batu, Selayang sponsored by Wilhelmsen Ship Services and Wilhelmsen Ship Management. The following trees planting programme was organized on the 15th of May 2017 at Kawasan Lapang Hijau in Kampung Cheras Baru, Kuala Lumpur and sponsored by Turner International (M) Sdn Bhd.

In February 2018, another trees planting activity was carried out with the sponsorship from Nur Power Sdn Bhd which took place in Lake Valley, Bandar Tun Hussein Onn, Cheras, Kuala Lumpur. In August 2018, YTL Corporation made an initiative to take part in the programme where Sentul Park was chosen as the venue. The Trees planting programme for 2018 ended in October with Program Penanaman Pokok MPSJ & Malakoff with Malakoff being the sponsor for this event, which took place in Putra Heights, Subang Jaya, Selangor.






LET'S BREAK UP WITH SINGLE-USE PLASTIC

Single-use plastics, or disposable plastics, are used only once before they are thrown away or recycled. These items include plastic bags, straws, coffee stirrers, soda and water bottles and most food packaging.

Petroleum based plastics are not biodegradable and usually go into a landfill where they are buried or they get into the water and find their way into the ocean. Although plastics will not biodegrade i.e. decompose into natural substance like soil, they will break down into tiny particles after many years. In the process of breaking down, they release toxic chemicals, and the additives that were used to shape and harden the plastic, which will make their way into our food and water supply.

These toxic chemicals are now being found in our bloodstream and the latest research discovered that they disrupt the Endocrine system which can cause cancer, infertility, birth defects, impaired immunity and many other ailments. Other studies have highlighted the potential health effects of single-use plastics on human and animals.



Malaysia is a global player in plastic industry. We produce hundreds of millions of tons of plastic every year, most of which cannot be recycled. Environmental problems related to plastic waste have become a major problem in Malaysia where it has been ranked as 8th among the top ten countries with mismanaged plastic waste in the world. A study estimated that Malaysia had produced 0.94 million tons of mismanaged plastic wastes, of which 0.14 to 0.37 million tons may have been washed into the oceans. We need to use less plastic, move towards environmentally sustainable products and services.

Through the Ministry of Energy, Science, Technology, Environment and Climate Change (MESTECC), Malaysia has implemented the Roadmap Towards Zero Single-Use Plastic from 2018 leading up to 2030. Under this roadmap, the Government is moving towards zero-used plastic for a cleaner and healthier environment by 2030. Following this initiative, Yayasan Hijau Malaysia has started the Let's Break Up With Single-use Plastic campaign in September 2018. In this campaign, all staff under MESTECC and its agencies were urged to stop using single-use plastic during office hours, lunch breaks, in meetings and in all programmes organized by MESTECC and its agencies.






Many people assume that the environment is in no danger. They believe that with advancing technology, we do not need to worry about renewing natural resources, recycling, and finding new ways to produce energy.



Today, the world is faced with a multitude of complex sustainability challenges. At the crux of the matter, the solution is simple: a mindset change is the key.





NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 31 MARCH 2018

1 GENERAL INFORMATION

The Company is limited by guarantee, incorporated and domiciled in Malaysia.

The principal objects/activities of the Company are as follows:

- a) To promote, initiate, foster, develop and improve education in energy efficiency, green technology applications and green lifestyle practice at grassroots' level and for the Malaysian public.
- b) To be the green technology enabler for linking green lifestyle applications and to create new opportunities in the field of innovation, occupation and commercial applications of the green technologies that have been developed; to contribute towards green technology research and applications; to organise, carry out and support green lifestyle schemes for the improvement of the lifestyle of the Malaysian public.
- c) To conduct educational and awareness programmes to enhance the appreciation of green lifestyle at school and grassroots' level, particularly among the youths, women, men, community and non-governmental organisations; to encourage excellence in green energy research that will accord direct benefits to the Malaysian public and the global community; to promote international exchange programmes, sharing of knowledge and other green lifestyle practices through community activities and to organise, conduct and co-ordinate training courses, seminars, workshops and publication activities to fulfil the objects of the Foundation.

There have been no significant changes in the nature of these activities during the year.

The financial statements of the Company are presented in the functional currency, which is the currency of the primary economic environment in which the entity operates. The functional currency of the Company is Ringgit Malaysia as the sales and purchases are mainly denominated in Ringgit Malaysia and receipts from operations are usually retained in Ringgit Malaysia and funds from financing activities are generated in Ringgit Malaysia.

2 SIGNIFICANT ACCOUNTING POLICIES

2.1 BASIS OF ACCOUNTING

The financial statements of the Company have been prepared in accordance with Malaysian Financial Reporting Standards ("MFRSs"), International Financial Reporting Standards and the provisions of the Companies Act, 2016 in Malaysia. The financial statements have been prepared under the historical cost convention.

The following are accounting standards, amendments and interpretations of the MFRS framework that have been issued by the Malaysian Accounting Standards Board ("MASB") but have not been adopted by the Company.

2.2 PROPERTY, PLANT AND EQUIPMENT AND DEPRECIATION

Property, plant and equipment are stated at cost less accumulated depreciation and accumulated impairment losses, if any.

Depreciation is provided on a straight-line method so as to write off the cost of the assets over their estimated useful lives, as follows:

2.3 IMPAIRMENT OF NON-FINANCIAL ASSETS

At each balance sheet date, the Company assesses whether there is any indication that an asset may be impaired. If any such indication exists, the recoverable amounts of the assets are estimated. Irrespective of whether there is any indication of impairment, the Company tests an intangible asset with an indefinite useful life or an intangible asset not yet available for use for impairment annually.

When it is not possible to estimate the recoverable amount of an individual asset, the Company estimates the recoverable amount of the cash-generating unit to which the asset belongs.

Recoverable amount is the higher of the net selling price and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset.

If the recoverable amount of an asset (or a cash-generating unit) is less than its carrying amount, an impairment loss is recognised to reduce the carrying amount to its recoverable amount. An impairment loss for a cash-generating unit is firstly allocated to reduce the carrying amount of goodwill allocated to the cash-generating unit, and then, to the other assets of the unit pro rata on the basis of the carrying amount of each asset in the unit.

An impairment loss is recognised immediately in income statement, unless it reverses a previous revaluation, in which case it is treated as a revaluation decrease.

An impairment loss recognised in prior periods for an asset is reversed if there has been a change in the estimate used to determine the asset's recoverable amount. An impairment loss is reversed only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation if no impairment loss had been recognised, and is recognised immediately in income statement, unless it reverses a previous revaluation, in which case it is treated as a revaluation increase.

2.4 FINANCIAL INSTRUMENTS

(a) Initial Recognition and Measurement

The Company recognises a financial asset or a financial liability (including financial instruments) in the statement of financial position when, and only when, an entity in the Company becomes a party to the contractual provisions of the instrument.

If a contract, whether financial or non-financial, contains an embedded derivative, the Company assesses whether the embedded derivative shall be separated from the host contract on the basis of the economic characteristics and risks of the embedded derivative and the host contract at the date when the Company becomes a party to the contract. If the embedded derivative is not closely related to the host contract, it is separated from the host contract and accounted for as a stand-alone derivative. The Company does not make a subsequent reassessment of the contract unless there is a change in the terms of the contract that significantly modifies the expected cash flows or when there is a reclassification of a financial asset out of the fair value through profit or loss category.

On initial recognition, all financial assets and financial liabilities (including government loans at below market interest rates) are measured at fair value plus transaction costs if the financial asset or financial liability is not measured at fair value through profit or loss. For instruments measured at fair value through profit or loss, transaction costs are expensed to profit or loss when incurred.

(b) Derecognition of Financial Instruments

For derecognition purposes, the Company first determines whether a financial asset or a financial liability should be derecognised in its entirety as a single item or derecognised part-by-part of a single item or of a group of similar items.

A financial asset, whether as a single item or as a part, is derecognised when, and only when, the contractual rights to receive the cash flows from the financial asset expire, or when the Company transfers the contractual rights to receive cash flows of the financial asset, including circumstances when the Company acts only as a collecting agent of the transferee, and retains no significant risks and rewards of ownership of the financial asset or no continuing involvement in the control of the financial asset transferred.

A financial liability is derecognised when, and only when, it is legally extinguished, which is either when the obligation specified in the contract is discharged or cancelled or expires. A substantial modification of the terms of an existing financial liability is accounted for as an extinguishment of the original financial liability and the recognition of a new financial liability. For this purpose, the Company considers a modification as substantial if the present value of the revised cash flows of the modified terms discounted at the original effective interest rate is different by 10% or more when compared with the carrying amount of the original liability.

(c) Subsequent Measurement

For the purpose of subsequent measurement, the Company classifies trade and other receivables, advances to related parties, and cash and cash equivalents in the category of loans and receivables. The Company has no other categories of financial assets.

After initial recognition, the Company measures: (i) financial assets in the loans and receivables category as at amortised cost using the effective interest method; and (ii) financial liabilities comprise trade and other payables and advances from related parties. After initial recognition, the Company measures all financial liabilities at amortised cost using the effective interest method.

(d) Recognition of Gains and Losses

For financial assets and financial liabilities carried at amortised cost, a gain or loss is recognised in profit or loss only when the financial asset or financial liability is derecognised or impaired, and through the amortisation process of the instrument.

(e) Impairment and Uncollectibility of Financial Assets

The Company applies the incurred loss model to recognise impairment losses of financial assets. At the end of each reporting period, the Company examines whether there is any objective evidence that a financial asset or a group of financial assets is impaired. Evidence of trigger loss events include: (i) significant difficulty of the issuer or obligor; (ii) a breach of contract, such as a default or delinquency in interest or principal payment; (iii) granting exceptional concession to a customer, (iv) it is probable that a customer will enter bankruptcy or other financial reorganisation, (v) the disappearance of an active market for that financial asset because of financial difficulties; or (vi) any observable market data indicating that there may be a measurable decrease in the estimated future cash flows from a group of financial assets.

For a non-current loan and receivable carried at amortised cost, the revised estimated cash flows are discounted at its original effective interest rate. Any impairment loss is recognised in profit or loss and a corresponding amount is recorded in an allowance account. Any subsequent reversal of impairment loss of the financial asset is reversed in profit or loss with a corresponding adjustment to the allowance account, subject to the limit that the reversal should not result in the revised carrying amount of the financial asset exceeding the amount that would have been determined had no impairment loss been recognised previously.

For short-term trade and other receivables, where the effect of discounting is immaterial, impairment loss is tested for each individually significant receivable wherever there is any indication of impairment. Individually significant receivables for which no impairment loss is recognised are grouped together with all other receivables by classes based on credit risk characteristics and aged according to their past due periods. A collective allowance is estimated for a class group based on the Company's experience of loss ratio in each class, taking into consideration current market conditions

2.5 CASH AND CASH EQUIVALENTS

Cash and cash equivalents comprise cash and bank balances, short-term deposits and other short-term, highly liquid investments that are readily convertible to a known amount of cash with an insignificant risk of changes in value.

2.6 GOVERNMENT GRANT

Government grants are recognised when there is reasonable assurance that the Company will comply with the conditions attaching to them and the grants will be received.

Government grants are recognised as income on a systematic basis over the periods necessary to match them with the related costs which they are intended to compensate.

Government grants related to assets are presented in the statement of financial position by setting up the grant as deferred income while government grant related to income is presented as a credit in profit or loss separately.

2.7 REVENUE

Revenue from projects is accounted upon the stage of completion of project work.

Revenue from event organising is recognised upon service rendered and customers acceptance, net of discount.

2.8 EMPLOYMENT BENEFITS

i) Short-Term Employment Benefits

Short-term employment benefits, such as wages, salaries and social security contributions, are recognised as an expense in the year in which the associated services are rendered by employees of the Company.

Short-term accumulating compensated absences, such as paid annual leave, are recognised when the employees render services that increase their entitlement to future compensated absences. Non-accumulating compensated absences, such as sick and medical leaves, are recognised when the absences occur.

The expected cost of accumulating compensated absences is measured as the additional amount expected to be paid as a result of the unused entitlement that has accumulated at the balance sheet date.

Profit-sharing and bonus plans are recognised when the Company has a present legal or constructive obligation to make payments as a result of past events and a reliable estimate of the obligation can be made. A present obligation exists when, and only when the Company has no realistic alternative but to make the payments.

ii) Defined Contribution Plan

Contributions to the statutory pension scheme are recognised as an expense in income statement in the year to which they relate.

2.9 INCOME TAX

Income tax comprises of current tax and deferred tax. Current tax and deferred tax are charged or credited to equity if the tax relates to items that are credited or charged directly to equity.

Current tax liabilities are measured based on the amounts expected to be paid, using the tax rates that have been enacted or substantially enacted by the balance sheet date.

Deferred tax is provided in full, using the liability method, on temporary differences which are the differences between the carrying amount in the financial statements and the corresponding tax base of an asset or liability at the balance sheet date.

Deferred tax liabilities are recognised for all taxable temporary differences and deferred tax assets are recognised for all deductible temporary differences to the extent that it is probable that taxable profit will be available against which the deductible temporary differences can be utilised. Deferred tax liabilities and assets are not recognised if the temporary differences arise from goodwill and for initial recognition of assets or liabilities that affect neither accounting profit nor taxable profit. Deferred tax liabilities and assets reflect the tax consequences that would follow from the manner in which the entity expects to recover or settle the carrying amounts of its assets and liabilities and are measured using the tax rates that have been enacted or substantially enacted by the balance sheet date.

The carrying amount of the deferred tax assets are reviewed at each balance sheet date, and the carrying amount is reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the asset to be utilised. The reduction is reversed to the extent that it becomes probable that sufficient taxable profit will be available.

3 SIGNIFICANT ACCOUNTING JUDGMENTS, ESTIMATES AND ASSUMPTIONS

Significant areas of estimation, uncertainty and critical judgments in applying accounting policies that have significant effect in determining the amount recognised in the financial statements include the following:

3.1 LOSS ALLOWANCES OF FINANCIAL ASSETS

The Company recognises impairment losses for receivables using the incurred loss model. At the end of each reporting period, the Company assesses whether there is any objective evidence that loans and receivables is impaired. Individually significant loans and receivables are tested for impairment separately by estimating the cash flows expected to be recoverable. The actual eventual losses may be different from the allowance made and this may affect the Company's financial position and results.

3.2 DEPRECIATION OF PROPERTY, PLANT AND EQUIPMENT

The cost of an item of property, plant and equipment is depreciated on the straight-line method or another systematic method that reflects the consumption of the economic benefits of the asset over its useful life. Estimates are applied in the selection of the depreciated method, the useful lives and the residual values. The actual consumption of the economic benefits of the property, plant and equipment may differ from the estimates applied and this may lead to a gain or loss on an eventual disposal of an item of property, plant and equipment.

3.3 MEASUREMENT OF INCOME TAXES

Significant judgment is required in determining the Company's provision for current and deferred taxes. When the final outcome of the taxes payable is determined with the tax authorities, the amount might be different from the initial estimates of the taxes payable. Such differences may impact the current and deferred taxes in the period when such determination is made. The Company will adjust for the differences as over or under provision of current or deferred taxes in the current period in which those differences arise.

13 FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The financial risk management is integral to the development of the Company's business. The Company has in place the financial risk management policies to manage its exposure to a variety of risks to an acceptable level. The Company's principal financial risk management policies are as follows:

13.1 CREDIT RISK

Cash and bank balances are placed with financial institutions with good credit rating. The Company placed funds in respect of other financial assets by reference to the investment evaluation procedures to ensure that the credit risk is kept at minimum level.

The carrying amounts of the financial assets recorded on the statement of financial position at the reporting date represent the Company's maximum exposure to credit risk in relation to financial assets. No financial assets carry a significant exposure to credit risk other than those disclosed in the notes.

The Company does not hold any collateral and thus, the credit exposure is continuously monitored by the Trustees.

13.2 LIQUIDITY RISK

The Company's funding requirements and liquidity risk are managed with the objective of meeting business obligations on a timely basis. The Company monitors its cash flows and ensures that sufficient funding is in place to meet the obligations as and when they fall due.

14 AUTHORISATION FOR ISSUE OF THE FINANCIAL STATEMENTS

The financial statements of the Company were authorised for issue by the Board of Trustees on 3 September 2018.
